TRANSPORT CANADA PERMIT FOR EQUIVALENT LEVEL OF SAFETY

AirNet II is also authorized by Transport Canada under permit number SA 8818, which recognizes our party status to DOT SP-15227 and allows us to operate with the same special status in Canada's air space. This special permit enables us to provide the highest level of radiopharmaceutical shipment service between Canada and the United States.


